1. WHAT IS BRICKS MADE OF WORDS: BUILDING EUROPE AGAIN THROUGH DIALOGUE

"Bricks Made of Words: building Europe again through dialogue" is a project dedicated to young European citizens interested in sharing knowledge and perspectives about actual key themes relevant for their future, as well as for the European Unions' future:

- EU bodies | civic rights and duties
- EU values (peace and tolerance)
- Civil rights and media freedom
- Migration and human rights
- Youth policies

The project will select 28 youngsters (18-24 years old) from different European Countries (Belgium, Bosnia Herzegovina, Italy, Romania, Serbia - Portugal and Cyprus to be confirmed) according to their orientation towards EU policies related to the selected themes (Euro sceptics and Euro supporters) and will bring them together in 6 Events held in Italy, Republic of Serbia, Romania, Bosnia Herzegovina, Belgium and Cyprus (to be confirmed).

During the 6 Events, youngsters will be involved in laboratories, workshops and study visits and will experiment innovative way of debate and knowledge sharing (storytelling, augmented reality, Lego gaming...).

Starting from knowing EU history and values, EU bodies and their functioning, participants will develop critical thinking on sensitive matters, debating and exchanging their thoughts with peers from other EU Countries, for finally developing a document containing all their ideas and recommendation to be presented in Brussels to the EU policy makers during the last event.

The project is co-founded by the Europe for Citizens Program of the European Union.

2. REASONS WHY TO PARTICIPATE THE PROJECT

- Interested in traveling to 6 EU Countries and explore them
- Interested in meeting youngsters from different Countries, living a real intercultural experience

- Curious about experimenting innovative ways to gather knowledge on the themes tackled (augmented reality | storytelling | Lego Serious Play)
- Interested in having your say to EU institutions, co-designing recommendations to be presented in Bruxelles during the last mobility.

3. WHAT PARTICIPANTS ARE SUPPOSED TO DO DURING THE PROJECT?

Participants will be involved in the following activities:





- Participate 1 focus group about European policies with the other selected youngsters in their Country
- Participate all the 6 Events of the project (details below)
- Remain in touch with the participants of the other Countries, sharing information and impressions through an online database
- Share project results and findings with their peers during local activities

EXPECTED RESULTS	 The main expected impacts on local and international participants are: Enlarge participants knowledge and involvement in EU history and its values; Stimulate reflection and debate regarding public participation; the presence of fake news; media freedom; Support the understanding of why the presence of a united Europe can allow to avoid wars, fostering peace and an healthy democratic process. Fostering the understanding of the personal growth added value due to cultural exchange.
